BE IT FURTHER RESOLVED, that the claimants shall not be obligated to pay any additional permit fees or costs associated with any permits required to be obtained from The City of San Diego relating to the project modifications required by The City of San Diego.

BE IT FURTHER RESOLVED, that the claimants shall not be obligated to reimburse the Planning Department for the deficit in the project account.
