WHEREAS, starting with four residents, the Association has grown to over 280 members committed to fight against crime; and

WHEREAS, the Association has worked with the San Diego Police Department and businesses in the community to put up more lighting, trim trees, clean up the lots, conduct graffiti paint-outs, stop the selling of drugs, and gang paraphernalia; and


WHEREAS, the Association put on its first Street Fair/Job Fair at the corner of Skyline Drive and Meadowbrook Drive in 1991; and
