MAINTENANCE DISTRICT.


WHEREAS, the notice of the time and place fixed for the hearing of protests in the matter of "Downtown Maintenance District," under Resolution of Intention No. R-280156, adopted on June 22, 1992, having been duly given in the manner required by law and the legal time for filing such protests and the time fixed for hearing thereon having passed; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. The protests, if any, are overruled.
2. The assessments described in Document No. RR-280157, on file in the office of the City Clerk and on file in the office of the Street Superintendent, are hereby confirmed and approved.
3. The modified assessment district map for the "Downtown Maintenance District," including the territory annexed by these proceedings as described in Document No. M-272-1 is hereby approved.
4. The maintenance described in said Resolution of Intention is hereby ordered performed.
5. In performing the administration and organization of the Downtown Maintenance District, the City Manager shall seek the

advice and the appropriate input from the Central City Association.
