RESOLUTION NUMBER R- 280350

ADOPTED ON JUL 20 1992

WHEREAS, San Dieguito Surf Soccer Club is a nonprofit organization for children and young adults, organized to help kids make goals through soccer; and

WHEREAS, Surf Soccer endeavors to teach youth about life situations in a controlled environment where loyalty and intense desire reign supreme; and

WHEREAS, Surf Soccer Club represents the San Dieguito Youth Soccer League at the highest levels of competitive youth soccer; and

WHEREAS, San Dieguito Youth Soccer League is composed of the soccer clubs of Solana Beach, Del Mar, Cardiff, Leucadia, Encinitas, Rancho Santa Fe, Carlsbad, La Costa, and North City West-San Diego; and

WHEREAS, Surf Soccer has conducted the Surf Soccer Tournament for 11 years; and

WHEREAS, the community, as well as the youth, benefit from the Surf Tournament; and

WHEREAS, 216 teams participated in the 11th Surf Tournament; and

WHEREAS, over 7,800 girls and boys ages 9-19, coaches and parents participated in the 11th Surf Tournament; and

WHEREAS, the players, coaches and parents represent 7 states and 2 foreign countries at the 11th Surf Tournament; and

WHEREAS, over 4,500 visitors were brought to the Del Mar-Solana Beach area during the 11th Surf Tournament; and

WHEREAS, the visitors booked over 1,800 hotel rooms (5,192 room days) during the tournament; and

WHEREAS, the participants in the tournament directly spent in the community over \$1 million for lodging, food, and entertainment during the 11th Surf Tournament; and

WHEREAS, the overall economic impact in the community was over \$3 million for the 11th Surf Tournament; and

WHEREAS, the official name "San Dieguito Surf Soccer Tournament" has been changed to "San Diego Surf Cup" in order to make the name more recognizable to out of state and international teams; and

WHEREAS, through the benefice and civic mindedness of the members and Board of Directors of the Rancho Santa Fe Polo Club, San Diego Surf Cup XII will offer players 20 of the best playing fields in the world; and

WHEREAS, in association with the Rancho Santa Fe Polo Club, the San Dieguito Surf Soccer Club will be hosting the 12th Annual San Diego Surf Cup at the Rancho Santa Fe Polo Grounds in Solana Beach, California; and

WHEREAS, over 250 teams will participate in this year's 12th Annual San Diego Surf Cup; and

WHEREAS, the economic impact to the area will be over \$3,500,000 with over 10,000 participants; and

WHEREAS, the tournament will be held July 31 through August 2, 1992 and August 7 through 9, 1992; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego,

that July 31 through August 9, 1992 be and is hereby proclaimed
to be "SAN DIEGO SURF CUP SOCCER DAYS" in San Diego.
