WHEREAS, Z-90 sponsored an Easter Day celebration for over 2,000 children and their families with food and give-aways; and

WHEREAS, Z-90 has sponsored numerous street fairs in conjunction with the San Diego Police Department to help set up community and neighborhood watch groups to fight crime; and

WHEREAS, Z-90 has assisted City Schools with the Drug Abuse Resistance Education (D.A.R.E.) Program to promote an anti-drug and anti-gang environment in our community; and

WHEREAS, during the Los Angeles riot, Z-90 showed sensitivity through its special musical format style that featured gentle, peaceful and community spirited types of music; and

WHEREAS, during the Los Angeles riot, Z-90 operated a call in line for frustrated citizens and continued to broadcast a message of "Keep the Peace" and "Support Your Local Police;" and

WHEREAS, during the Los Angeles riot, Z-90 worked hand-in-hand with Councilman Stevens in co-sponsoring a public forum at Lincoln High School, allowing the general public to ask questions and receive answers, thereby venting their anger in a non-destructive manner; NOW, THEREFORE,

that this Council, for and on behalf of the people of San Diego,
hereby proclaims July 20, 1992, to be "Z-90 RADIO STATION DAY" in
San Diego, and commends Z-90 for its outstanding leadership, and
