RESOLUTION NUMBER R- 280358

ADOPTED ON JUL 20 1992

WHEREAS, RIMPAC is an international naval exercise which is scheduled biennially with Pacific Rim nations involved in underway operations at sea and in-port training; and

WHEREAS, The City of San Diego is host to RIMPAC 1992; and

WHEREAS, this is the first time since RIMPAC was established in 1971 that the exercise is being held in local San Diego waters; and

WHEREAS, RIMPAC 1992 participants include five Pacific Rim nations and over 45 ships, 200 aircraft and 20,000 sailors, air personnel, Marines and coast guard personnel from the United States; Japan, Australia, Canada and the Republic of Korea; and

WHEREAS, RIMPAC 1992 serves to promote cooperation and goodwill among the allies of the United States; and

WHEREAS, naval personnel from Japan, Australia, Canada and the Republic of Korea will be visiting in San Diego during RIMPAC 1992 which is being conducted between June 18 and August 2; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council, for and on behalf of the people of San Diego, extends their friendship and appreciation to RIMPAC 1992 participants.

BE IT FURTHER RESOLVED, that July 23 through 30, 1992 be and is hereby proclaimed to be "RIMPAC 1992 WEEK" in San Diego.
