BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is hereby authorized to execute, for and on behalf of The City of San Diego, a document entitled "Western Loop Road Joint Use Agreement" with PASADENA COLLEGE, dba POINT LOMA NAZARENE COLLEGE, a California nonprofit corporation, (hereinafter "the College"), which grants the College the non-exclusive right, for a period of 25 years, to use an existing road located on a portion of Sunset Cliffs Natural Park, with public access to also be allowed through the College property to the road, under the terms and conditions set forth in that Western Loop Road Joint Use Agreement on file in the office of the City Clerk as Document No. RR-280373 - 1.
