WHEREAS, the City Council recognized the formation of the Partnership for San Diego ("Partnership") Committee by Resolution No. R-279776, on April 20, 1992; and

WHEREAS, Partnership was formed for the purpose of addressing the quality of life issues in a balanced and responsible manner; and

WHEREAS, to accomplish this objective, Partnership has developed a three-phased program, where Phase I is the development of a "Vision" statement, Phase II is the development of quality of life standards, and Phase III is a test and fine-tuning program to assess how the Vision and Standards apply to various documents and proposals, assuring a realistic final product; and

WHEREAS, on July 15, 1992, Partnership completed and approved the Phase I "Vision" statement which will be used as a basis for the development of "Quality of Life Standards (Phase II) which will be brought forward for conceptual approval by the City Council on September 11, 1992; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the Phase I "Vision" statement prepared by the Partnership for San Diego Committee, attached hereto as Attachment A, be and

is hereby conceptually approved as a basis for the development of
"Quality of Life Standards" (Phase II).
