perform the required services to provide gas and electric services to the pump station near Perez Cove, for a fee not to exceed \$50,000.00, in connection with CONSTRUCTION OF MISSION BAY SEWAGE INTERCEPTOR SYSTEM, PHASES III AND IV.

BE IT FURTHER RESOLVED, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with PACIFIC BELL, to perform the required services to provide telephone conduits to service the telemetry at the pump station near Perez Cove, for a fee not to exceed \$150,000.00, in connection with CONSTRUCTION OF MISSION BAY SEWAGE INTERCEPTOR SYSTEM, PHASES III AND IV.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$1,971,100.00 from Sewer Revenue Fund 41506, CIP 46-158.0, contingent upon City Council approval of the FY 1993 CIP budget, is hereby authorized solely and exclusively for providing funds for said project and related costs.
