RESOLUTION NUMBER R- 280417

ADOPTED ON JUL 27 1992

WHEREAS, the Police Department of the City of San Diego wishes to accept and expend a grant award of five hundred and thirty-seven thousand six hundred and twenty-four dollars (\$537,624.00) for a program entitled "DUI and Collision Reduction Program" from the National Highway Traffic Safety Administration, and administered by the California Office of Traffic Safety; and

WHEREAS, the grant award will be used to enhance the San Diego Police Department's Drunk Driver Detection Program by increasing staffing, detecting lower blood alcohol levels with greater precision, and reducing hit-and-run collisions; and

WHEREAS, the program will enhance the Police Department's Traffic Safety and Education Program aimed at reducing drinking and driving and increasing pedestrian safety; and

WHEREAS, the program will enhance the Police Department's Speed Enforcement Program; NOW THEREFORE

BE IT RESOLVED, by the Council of the City of San Diego, that the City Manager be, and is hereby, authorized to submit the Grant Application Proposal, a copy of which is on file in the Office of the City Clerk as Document No. RR-280417, to the California Office of Traffic Safety; and is further authorized to execute the grant proposal program, including any extensions or amendments thereof.

BE IT FURTHER RESOLVED, that the City of San Diego shall provide all matching funds required for said project, including any amendments thereof, under the program and the funding terms and conditions of the Office of Traffic Safety, and that the cash match will be designated as required.

BE IT FURTHER RESOLVED AND AGREED, that any liability arising out of the performance of the Grant Award Agreement, including civil court action for damages, shall be the responsibility of the grant recipient and the authorizing agency; the Federal Government, the National Highway Traffic Safety Association, and the California Office of Traffic Safety disclaim responsibility for any such liability.

BE IT FURTHER RESOLVED, that any grant funds received hereunder shall not be used to supplant expenditures controlled by this body.
