

RESOLUTION NUMBER R-280429

ADOPTED ON JULY 27, 1992

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and is hereby authorized and empowered, for and on behalf of the City, to: (1) have the International Boundary and Water Commission (IBWC) proceed with the design of a South Bay Land Outfall Extension and Ocean Outfall, with a capacity of 132 million gallons per day average and 258 million gallons per day peak; (2) acquire the right-of-way for the outfall; (3) delay until further action of this Council plans to acquire the site for the South Bay Treatment Plants; and (4) modify the existing cost sharing formula and Memorandum of Agreement with the IBWC, the Environmental Protection Agency, and the State Water Resources Control Board, all as outlined in City Manager's Report No. CMR-92-239, on file in the office of the City Clerk as Document No. RR-280429.

BE IT FURTHER RESOLVED, that the City Manager is directed to negotiate with the Environmental Protection Agency and the IBWC to obtain a dollar for dollar credit for all City costs of treating Tijuana sewage to be applied as a credit to the City's contribution for construction of the South Bay Outfall Extension.
