RESOLUTION NO. R - 280430
ADOPTED ON JUL 27 1992

WHEREAS, America's cities have experienced significant deterioration during the past decade due in part to the withdrawal of federal urban aid; and

WHEREAS, the health of this nation is directly related to the health of its cities; and

WHEREAS, the San Diego City Council has reviewed Resolution No. 47 adopted this year by the U.S. Conference of Mayors at its Annual Conference in Houston; and

WHEREAS, the San Diego City Council shares the position expressed in Resolution No. 47 that the nation's cities are in need of emergency federal assistance to create jobs and attend to the social and infrastructure problems which threaten to overwhelm them; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council hereby expresses its strong support for Resolution No. 47 and the U.S. Conference of Mayors' efforts to persuade Congress to pass an emergency urban aid bill.

BE IT FURTHER RESOLVED, that the Council hereby directs the Department of Legislative Services to prepare letters on behalf of the City expressing the Council's position and urging Congress

to act soon to address these critical needs for jobs and urban aid which will assist in restoring economic vigor and hope to the nation's cities.
