AL ARCHARD INC. are hereby accepted and the City Manager is hereby authorized to execute contracts for the purchase of TIRES AND TUBES as may be required for a period of one (1) year beginning September 1, 1992 through August 31, 1993 per prices on file in the Purchasing Department as follows:

1. PARKHOUSE TIRE, INC. for Group I - Radial/Tubeless, Passenger Car/Compact Truck; Group IV - Radial/Bias Tube and Tubeless, Medium/Heavy Duty Truck; and Group V - Bias/Tube, Off-Road Tire, for a total estimated cost of \$344,469.00; terms net 30 days, plus sales tax.
2. TALIN TIRE INC. for Group II - Radial Police High Speed; Group III - Radial/Bias Tube and Tubeless, Light Trucks; and Group VI - Miscellaneous Fire Department Trucks Tires, for a total estimated cost of \$197,301.00; terms 2% 25 days, plus sales tax.
3. AL ARCHARD INC. for Group VII - Inner Tubes, for a total estimated cost of \$7,167.00; terms net 30 days, plus sales tax.
