BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is hereby authorized and empowered to execute, for and on behalf of the City, an agreement with Alpha Project For The Homeless, to provide litter removal services in Centre City East, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR- 280523, together with any reasonably necessary modifications or amendments thereto which do not increase the above project's scope or cost and which the City Manager shall deem necessary from time to time in order to carry out the purposes and intent of this project and agreement.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$25,000 from Fund 70212, Downtown Maintenance District, is hereby authorized, solely and exclusively to provide funds for this project.
