BE IT RESOLVED, by the Council of The City of San Diego that the low bid of ATLAS PUMPING SERVICE is hereby accepted and the City Manager is hereby authorized to execute a contract for furnishing WASTEWATER REMOVAL FROM PORTABLE TOILETS AND HOLDING TANKS located at City reservoirs as may be required for a period of one (1) year beginning September 1, 1992 through August 31, 1993 per prices on file in the Purchasing Department, for a total estimated cost of \$58,317.60; terms 1% 20 days, with options to renew the contract for four (4) additional one (1) year periods, with option period price increases not to exceed 10% of the prices in effect in each prior period.
