

RESOLUTION NUMBER R- 280565

ADOPTED ON SEP 14 1992

BE IT RESOLVED, by the Council of The City of San Diego that the low bids of 1. INDUSTRIAL TOOL, 2. KNOX INDUSTRIAL SUPPLIES, 3. CAL-WEST PRODUCTS, INC. and 4. CONTINENTAL TOOL & HOIST are hereby accepted and the City Manager is hereby authorized to execute contracts for the purchase of MISCELLANEOUS SMALL TOOLS as may be required for a period of one (1) year beginning September 1, 1992 through August 31, 1993 per prices on file in the Purchasing Department as follows:

1. INDUSTRIAL TOOL for Section I - Files; Section II - Gardening & Miscellaneous; Section V - Shovels and Handles; and Section IX - Wrenches, for a total estimated cost of \$129,641.00; terms net 30 days, plus sales tax, with options to renew contract for four (4) additional one (1) year periods at prices not to exceed 7% of prices in effect at the end of prior contract periods.
2. KNOX INDUSTRIAL SUPPLIES for Section III - Hammers & Handles, for a total estimated cost of \$9045.00; terms net 30 days, plus sales tax, with options to renew contract for four (4) additional one (1) year periods, with total increases for the entire period not to exceed 20%.

3. CAL-WEST PRODUCTS, INC. for Section IV - Pliers and Section VI - Screwdrivers, for a total estimated cost of \$25,116.00; terms net 30 days, plus sales tax, with options to renew contract for four (4) additional one (1) year periods, with prices not to exceed 10% of prices in effect at end of prior contract periods.
4. CONTINENTAL TOOL & HOIST for Section VII - Sockets & Socket Wrench Accessories, and Section VIII - Impact Sockets & Accessories, for a total estimated cost of \$47,231.00; terms net 30 days, plus sales tax, with options to renew contract for four (4) additional one (1) year periods, with prices not to exceed 8% of prices in effect at end of prior contract periods.
