BE IT RESOLVED, by the Council of The City of San Diego that the low bids of 1. BORDER PRODUCTS CORP. and 2. ATLAS/SCA CONSTRUCTION SUPPLY are hereby accepted and the City Manager is hereby authorized to execute contracts for the purchase of MISCELLANEOUS CEMENTITIOUS BUILDING MATERIALS as may be required for a period of one (1) year beginning August 15, 1992 through August 14, 1993 per prices on file in the Purchasing Department, with options to renew the contract for four (4) additional one (1) year periods, with price increases not to exceed 10% for Items 1, 2, 3 and 5% for Items 4, 5 of the prices in effect at the end of each prior period, with awards as follows:

1. BORDER PRODUCTS CORP. for Items 1, 2 and 3, Portland Cement, Red-E-Crete Mix and Non Shrink Grout, for an estimated annual cost of \$23,771.81; terms net 30 days.
2. ATLAS/SCA CONSTRUCTION SUPPLY for Items 4 and 5, Re-Crete 5 min. compound patch and Re-Crete 20 min. compound patch, for an estimated annual cost of \$23,597.25; terms 1% 10, net 30 days.


