BE IT RESOLVED, by the Council of The City of San Diego that the specifications for the furnishing of all labor, material, tools, equipment, transportation and other expense necessary or incidental for ARCHITECTURAL REMODELING OF FOUR BALBOA PARK BUILDINGS, San Diego, California, on file in the Office of the City Clerk of San Diego, California on SEP 14 1992, and bearing official document No. W.O. 119471, be and the same are hereby approved.

BE IT FURTHER RESOLVED, that the Purchasing Agent of the City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with the law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for ARCHITECTURAL REMODELING OF FOUR BALBOA PARK BUILDINGS.

BE IT FURTHER RESOLVED, that the expenditure of \$1,330,386.00 from CIP No. 21834.0, BALBOA PARK/MISSION BAY PARK REQUIREMENTS, of which \$1,306,606.00 is from San Diego Facility and Equipment Leasing Construction Fund 91101, and \$23,780.00 is from Capital Outlay Other Fund No. 302453, is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.


