BE IT FURTHER RESOLVED, that the Purchasing Agent of the City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with the law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for REPLACEMENT OF TRAFFIC SIGNAL CONTROLLERS AT VARIOUS LOCATIONS.

BE IT FURTHER RESOLVED, that the expenditure of \$300,000.00 from CIP 63-002.0, ANNUAL ALLOCATION - REPLACE OBSOLETE TRAFFIC SIGNAL CONTROLLERS, (\$150,000.00 from Fund 30219, and \$150,000.00 from Fund 30300), is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller upon advice from the administering department, to retain excess monies, if any, in CIP 63-002.0.
