RESOLUTION NUMBER R- 280603

ADOPTED ON SEP 14 1992

WHEREAS, Government Code section 87306.5 and Resolution R-280174 adopted by the City Council on June 22, 1992, require City boards and commissions to renew their conflict of interest codes and update them to reflect current law and circumstances; and

WHEREAS, the Conflict of Interest Code for the City's Funds Commission was adopted on April 27, 1977 by Resolution R-218251, and has never been updated; and

WHEREAS, upon review of the law, it has been determined that the Funds Commission no longer is required to have a Conflict of Interest Code, since members of the Funds Commission are "public officials who manage public investments" and therefore must file Statements of Economic Interest (721 disclosure form) pursuant to Government Code sections 87200 through 87210, in lieu of Statements of Economic Interest under a Conflict of Interest Code (730 disclosure form); and

WHEREAS, the current Conflict of Interest Code is superseded and replaced by the requirements of Government Code sections 87200 through 87210; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the Conflict of Interest Code of the City's Funds Commission is hereby declared to be superseded by Government Code sections 87200 through 87210; and

BE IT FURTHER RESOLVED, by the Council that Resolution No.
R-218251 is hereby rescinded.
