RESOLUTION NUMBER R- 280618
ADOPTED ON SEP 14 1992

WHEREAS, the Police Department of The City of San Diego has been pre-approved to receive, and wishes to apply for, accept, and expend, an award of thirteen thousand dollars (\$13,000) entitled "Roadside Sobriety Checkpoint Mini-Grant" from the California Office of Traffic Safety; and,

WHEREAS, grant funds will be used to purchase a fully equipped trailer costing approximately eleven thousand dollars (\$11,000.00) to conduct driving under the influence (DUI) checkpoints with the goal of reducing drunk driving and resultant traffic accidents; and,

WHEREAS, the DUI checkpoints will be conducted in the Police Department's Southern Division by patrol officers who will be trained by Office of Traffic Safety materials; and,

WHEREAS, grant funds will also be used to purchase public information and educational materials concerning drinking and driving; and,

WHEREAS, there is no requirement for matching funds and no additional City personnel or resources will be required to implement the program; NOW THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be, and is hereby, authorized to submit the Grant

Application, a copy of which is in file in the Office of the City Clerk, as Document No. RR-280618, to the California Office of Traffic Safety, and he is further authorized to execute the grant proposal program, including any extensions or amendments thereof.

BE IT FURTHER RESOLVED AND AGREED, that any liability arising out of the performance of the Grant Award Agreement, including civil court action for damages, shall be the responsibility of the grant recipient and the authorizing agency; the State Government and the Office of Traffic Safety disclaim responsibility for any such liability.

BE IT FURTHER RESOLVED, that any grant funds received hereunder shall not be used to supplant expenditures controlled by this body.


