RESOLUTION NUMBER R- 280620

ADOPTED ON SEP 14 1992

WHEREAS, the Police Department of The City of San Diego desires to apply for, and if selected to accept and expend, a fourth-year grant award renewal of three hundred twenty-one thousand, two hundred fifty dollars (\$321,250.00) to be funded in part by funds made available through the Federal Bureau of Justice Assistance, a subsidiary agency of the Office of Justice Program, United States Department of Justice; and

WHEREAS, the grant award will be used to continue the operation of the Financial Investigations (FINVEST) Grant Program, the goal of which is the detection and seizure of hidden assets of drug dealers; and

WHEREAS, the Bureau of Justice Assistance will provide one hundred fifty thousand dollars (\$150,000.00), with the remaining one hundred seventy-one thousand, two hundred fifty dollars (\$171,250.00) required to continue operations at the present level furnished from previously budgeted city funds; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be, and is hereby, authorized to submit the Grant Application Proposal, a copy of which is on file in the Office of the City Clerk, as Document No. RR- 280620, to the Bureau of Justice Assistance; and he is further authorized to


execute the grant proposal program, including any extensions or amendments thereof.

BE IT FURTHER RESOLVED, that The City of San Diego shall provide all matching funds required for said project, including any amendments thereof, under the program and the funding terms and conditions of the Office of Criminal Justice Planning, and that the cash match will be designated as required.

BE IT FURTHER RESOLVED, that any liability arising out of the performance of the Grant Award Agreement, including civil court action for damages, shall be the responsibility of the grant recipient and the authorizing agency; the United States Department of Justice, the Office of Justice Programs, and the Bureau of Justice Assistance disclaim responsibility for any such liability.

BE IT FURTHER RESOLVED, that any grant funds received hereunder shall not be used to supplant expenditures controlled by this body.
