ADOPTED ON SEP 14 1992

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of the City, an agreement with American Ventures, Inc., for as-needed pipeline value engineering services for the Water Utilities Department, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR-280627, together with any reasonably necessary modifications or amendments thereto which do not increase this project's scope or cost and which the City Manager shall deem necessary from time to time in order to carry out the purposes and intent of this project and agreement.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer an amount not to exceed \$100,000 within Water Revenue Fund 41500, from CIP 73-083.0, Annual Allocation for Water Main Replacements, to Water Operations Engineering Program (70830); and to transfer an amount not to exceed \$100,000 within Sewer Revenue Fund 41506, from CIP 44-001.0, Annual Allocation for Sewer Main Replacements, to Sewer Operations Engineering Program (70820).

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$200,000, consisting of \$100,000 from Water Revenue Fund 41500, Water Operations Engineering Program (70830), and \$100,000 from Sewer Revenue Fund 41506, Sewer Operations Engineering Program (70820), is hereby authorized, solely and exclusively to provide funds for the above project.

BE IT FURTHER RESOLVED, that the City Manager is authorized to finance or refinance this agreement with tax exempt securities, if circumstances so warrant.
