BE IT RESOLVED, by the Council of The City of San Diego, that the low bid of IMPERIAL WEST CHEMICAL CO., is hereby accepted and the City Manager is hereby authorized to execute a contract for furnishing FERRIC CHLORIDE as may be required for a period of one (1) year beginning November 1, 1992 through October 31, 1993 at a delivered price of \$0.09955 per dry pound, for a total estimated cost of \$2,986,500.00; terms net 30 days plus sales tax, with options to renew for four (4) additional one (1) year periods with price escalations not to exceed 25% of prices in effect at the end of the prior year.

BE IT FURTHER RESOLVED, that in the event the contractor fails at any time during the contract period to deliver material meeting specifications, the Purchasing Agent is hereby authorized to obtain ferric chloride from either of the other two bidders under the terms of the emergency pricing agreement, or to obtain this material on the open market until the requirement can be rebid.
