A RESOLUTION TRANSMITTING THE CONSISTENCY
CHECKLIST FOR THE REGIONAL GROWTH MANAGEMENT
STRATEGY FROM THE CITY OF SAN DIEGO TO THE
SAN DIEGO ASSOCIATION OF GOVERNMENTS
(SANDAG).

WHEREAS, Proposition C, The Regional Planning and Growth
Control Measure, was approved by the voters in November 1988; and

WHEREAS, the Council of The City of San Diego on February 5,
1990, adopted the eighth amendment to the San Diego Association
of Governments (SANDAG) Joint Powers Agreement establishing the
Regional Planning and Growth Management Review Board to pursue
the Proposition C initiated Regional Growth Management Strategy;
and

WHEREAS, the Council of The City of San Diego on April 7,
1992, approved and adopted the Regional Growth Management
Strategy, which incorporates a Local/Regional Consistency
Checklist procedure for local planning status reporting to the
SANDAG Board of Directors acting as the Regional Planning and
Growth Management Review Board; and

WHEREAS, the Regional Growth Management Strategy includes a
self-certification process to ensure consistency between the
Strategy's Recommended Actions and the relevant plans, policies
and ordinances of local jurisdictions and regional agencies; and

WHEREAS, The City of San Diego has completed the Consistency
Checklist which provides a status report regarding the
consistency of its relevant plans, policies and ordinances with


the Strategy's Recommended Actions, and information regarding the region's progress towards achieving the Quality of Life Standards and Objectives; and

WHEREAS, the Council of The City of San Diego has held a public hearing on the Consistency Checklist; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council hereby approves and adopts the City's initial Local/Regional Consistency Checklist, a copy of which is on file in the office of the City Clerk as Document No. RR-280649.

BE IT FURTHER RESOLVED, that The City of San Diego hereby transmits the completed Consistency Checklist to the Regional Planning and Growth Management Review Road, and agrees to take the actions identified therein to achieve consistency with the strategy and to adopt a self-certification resolution after holding a public hearing.


WHEREAS, the Council of The City of San Diego has held a public hearing on the Consistency Checklist; NOW, THEREFORE,
