RESOLUTION NUMBER R- 280661

ADOPTED ON SEP 15 1992

WHEREAS, the Police Department of The City of San Diego desires to execute and expend a grant award of fifty-two thousand, eight hundred twenty-seven dollars (\$52,827.00) as its share of a total of two hundred, fifty thousand dollars (\$250,000.00) in grant funds for a program entitled, "Housing Commission Drug Elimination Plan," as developed and administered by the San Diego Housing Commission; and

WHEREAS, the San Diego Housing Commission, as the designated lead agency, in compliance with the allocation plan of the Federal Department of Housing and Urban Development, has completed and submitted the grant program proposal for Fiscal Year 1992-93; and

WHEREAS, the grant award will fund one San Diego Police Officer to provide walking patrol and community policing in designated public housing developments in the City Heights area; and

WHEREAS, additional components of the program, not operated by the San Diego Police Department, will provide: Youth Activities Coordinators for youth drug diversion programs; staffing for youth educational centers; drug awareness programs; and physical security upgrades in designated public housing developments in City Heights and San Ysidro; and

WHEREAS, the goal of the program is the elimination of drug-related activities in the targeted public housing sites; and

WHEREAS, there is no requirement for matching funds and no additional police department personnel will be required to implement and execute the program; NOW, THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be, and is hereby, authorized to accept the grant award, as described in the Grant Application Proposal, a copy of which is on file in the Office of the City Clerk as Document No. RR- 280661, to the Federal Department of Housing and Urban Development, and he is further authorized to execute the grant proposal program, including any extensions or amendments thereof.

BE IT FURTHER RESOLVED, that any liability arising out of the performance of the Grant Award Agreement, including civil court action for damages, shall be the responsibility of the grant recipient and the authorizing agency; the Federal Government and the Department of Housing and Urban Development disclaim responsibility for any such liability.

BE IT FURTHER RESOLVED, that any grant funds received hereunder shall not be used to supplant expenditures controlled by this body.
