ADOPTED ON SEP 15 1992

WHEREAS, September 1992 marks the 201st anniversary of the passage of the Bill of Rights, a signal event in the history of freedom in America; and

WHEREAS, the Bill of Rights, the first ten Amendments to the Constitution of the United States, guarantees to all Americans the rights of freedom of speech and religion, to assemble and petition, to bear arms, to privacy, to jury trials, to protection from self-incrimination, and other basic rights; and

WHEREAS, the County of San Diego in 1985 established the San Diego U.S. Constitution Observance Committee to celebrate the drafting and signing of the Constitution and the Bill of Rights over the six-year period of 1986-1992; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council, for and on behalf of the people of San Diego, does hereby designate the month of September 1992 as **"CONSTITUTIONAL OBSERVANCE MONTH."**

BE IT FURTHER RESOLVED, that the City Council encourages all residents of San Diego to attend the special festivities in Old Town State Park on September 19, 1992.

BE IT FURTHER RESOLVED, that this Council does hereby recognize and highly commend the outstanding commitment and accomplishments of the SAN DIEGO U.S. CONSTITUTION OBSERVANCE

COMMITTEE in leading this County during the past years in a
celebration of Constitutional Government.
