RESOLUTION NUMBER R-280683

ADOPTED ON SEP 21 1992

WHEREAS, in 1990 Government Code section 87306.5 was added to the Political Reform Act; and

WHEREAS, Government Code section 87306.5 requires that no later than July 1 of each even-numbered year, the City Council as the code reviewing body of local agencies' Conflict of Interest Codes, shall direct every local agency which has adopted a Conflict of Interest Code ("Code") to review its Code; and

WHEREAS, local agencies include not only City departments, but also City-owned Corporations, certain City board's and commissions, and certain other local agencies for whom the City Council serves as code reviewing body; and

WHEREAS, upon review of a local agency's Code, if no change in the Code is required, the local agency head shall submit a written statement to that effect to the code reviewing body no later than October 1 of the same year; and

WHEREAS, The City of San Diego's Centre City Development Corporation ("Corporation") is a "local agency" within the meaning of Government Code section 87306.5; and

WHEREAS, on October 2, 1978, the City Council by Resolution No. R-221934, adopted a Code governing this Corporation, and by Resolution No. R-278102, adopted on June 10, 1991, amended the Corporation's Code; and

WHEREAS, the Corporation's Executive Vice President has reviewed the Corporation's Code as amended on June 10, 1991, and has determined that no change to the Corporation's Code is required or recommended at this time; and

WHEREAS, the City Manager concurs in the recommendation not to change the Corporation's Code at this time; NOW, THEREFORE,

BE IT RESOLVED, by the City Council that the City Manager's recommendation be adopted and that no change to the Centre City Development Corporation's Conflict of Interest Code be made at this time.
