RESOLUTION OF THE COUNCIL OF THE CITY  
OF SAN DIEGO APPROVING THE APPLICATION  
AND ASSURANCES FOR GRANT FUNDING FOR  
ACQUISITION AND DEVELOPMENT PROJECTS  
WITHIN OTAY VALLEY REGIONAL PARK.

WHEREAS, the Legislature and the Governor of the State of California have approved a grant for the project shown above; and

WHEREAS, the State Coastal Conservancy has been delegated responsibility for administration of the grant project, setting up necessary procedures; and

WHEREAS, said procedures established by the State Coastal Conservancy require the City of San Diego to certify by resolution its approval of application(s) before submission of said application(s) to the state; and

WHEREAS, said application(s) contain assurances that the City must comply with; and

WHEREAS, the City will enter into an agreement with the State of California for the subject project; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the City Manager or his representative be and is hereby authorized to submit an application to secure funding as described in the Council docket supporting information.

2. That the City Council hereby certifies that it understands the assurances and certification in the application form.

3. That the City Council hereby certifies that it has or will have sufficient funds to operate and maintain the project.

4. That the City Council hereby certifies that it has reviewed and understands the General Provision contained in the state/local agreement shown in the Procedural Guide.

5. That the City Auditor and Comptroller be and is hereby authorized to establish a separate interest bearing account for this grant project.

6. That the City Manager or his representative be and is hereby authorized to conduct all negotiations, execute and submit all documents including but not limited to agreements, amendments, payment requests and so on, which may be necessary for completion of the above project.
