A RESOLUTION OF THE CITY COUNCIL OF THE  
CITY OF SAN DIEGO ESTABLISHING A CITY OF  
SAN DIEGO SUPPLEMENTAL PENSION SAVINGS  
PLAN-HOURLY FOR ELIGIBLE EMPLOYEES OF SAID  
CITY

WHEREAS, the City Council of The City of San Diego directed that the City withdraw from participation in the Social Security System effective January 1, 1982; and

WHEREAS, the City has declared that certain benefits shall be provided to employees in lieu of social security participation; and

WHEREAS, hourly employees have not been eligible to participate in the SPSP or SPSP/M plans; and

WHEREAS, hourly employees did not previously contribute to the Social Security System or any other retirement system; and

WHEREAS, the Omnibus Budget Reconciliation Act of 1990 (OBRA) requires all employees to have coverage under a retirement system; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the final plan document statement for the City of San Diego Supplemental Pension Savings Plan-Hourly, as set forth in the Plan Document attached hereto, which by this reference is fully incorporated herein, be and the same is hereby approved and adopted.

2. That the City Manager be, and he is hereby authorized to establish a Supplemental Pension Savings Plan-Hourly, (herein called "SPSP-H") for eligible employees of The City of San Diego, under the terms and conditions set forth in the Plan on file in the office of the City Clerk as Document No. RR-280705.

3. That the provisions of the Plan shall be effective and in full force on July 1, 1991.
