

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to expend an amount not to exceed \$80,000 from Fund 18528, Dept. 4022, Org. 2202, solely and exclusively, for the purpose of providing funds for the above project.
