ADOPTED ON SEP 22 1992

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO CALLING FOR THE FORMATION OF A PROJECT AREA COMMITTEE FOR THE PROPOSED COLLEGE COMMUNITY REDEVELOPMENT PROJECT AND ADOPTING A PROCEDURE FOR THE FORMATION OF THE PROJECT AREA COMMITTEE.

WHEREAS, the Council of The City of San Diego (the "Council") by Resolution No. 272350 adopted on November 15, 1988, approved a redevelopment survey area to study and determine the feasibility of a redevelopment project or projects within the College Community area; and

WHEREAS, the Planning Commission of The City of San Diego adopted a resolution on August 6, 1992, selecting a redevelopment project area from within the boundaries of the above-mentioned survey area and approving a preliminary plan for the redevelopment of the selected project area; and

WHEREAS, the Agency is preparing a redevelopment plan for the proposed College Community Redevelopment Project in accordance with the California Community Redevelopment Law; and

WHEREAS, pursuant to subdivision Section 33385(a) of the Community Redevelopment Law, the Council shall call upon the residents, businesses, and existing community organizations in the project area to form a project area committee; and

WHEREAS, pursuant to Section 33385(b) of the Community Redevelopment Law, the City Council shall, by resolution, adopt a procedure for the formation of the project area committee; and


WHEREAS, the Council has published and mailed notice of a City Council meeting this date to consider adoption of a proposed "Procedure for Formation of a Project Area Committee for the college Community Redevelopment Project" relative to the formation and selection of the Project Area Committee; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the Council hereby calls upon the residents, businesses and existing community organizations in the College Community Redevelopment Project Area to form a project area committee in accordance with the Community Redevelopment Law.

2. That the Council hereby adopts as the procedure for the formation of the project area committee, the "Procedure for Formation of a Project Area Committee for the college Community Redevelopment Project" in the form presented to this meeting and placed on file in the office of the City Clerk as Document No. RR- 280718.
