

RESOLUTION NUMBER R- 280720

ADOPTED ON SEP 29 1992

BE IT RESOLVED, by the Council of The City of San Diego that the low and low acceptable bids of 1. GRO-POWER., INC., 2. BUTLER'S MILL INC., 3. O. M. SCOTT & SONS CO., and 4. GRANGETTO AGRICULTURAL SUPPLY CO. are hereby accepted and the City Manager is hereby authorized to execute contracts for the purchase of FERTILIZERS AND SOIL CONDITIONERS as may be required for a period of one (1) year beginning August 15, 1992 through August 14, 1993, as follows:

1. GRO-POWER., INC. for Item 2 at an estimated cost of \$10,300; terms net 30 days, plus sales tax, with options to renew the contract for four (4) additional one (1) year periods with option period increases not to exceed 10% of the prices in effect at the end of the prior contract period.
2. BUTLER'S MILL INC. for Items 4, 5 and 6 at an estimated cost of \$4,271; terms net 30 days, plus sales tax, with options to renew the contract for four (4) additional one (1) year periods with option period increases not to exceed 8% of the prices in effect at the end of the prior contract period.
3. O. M. SCOTT & SONS CO. for Items 1 and 3 at an estimated cost of \$27,840; terms net 30 days, plus sales tax, with an option to renew the contract for one (1) additional one (1)

year period with an option period increase not to exceed 5% of the prices in effect at the end of the initial contract period.

4. GRANGETTO AGRICULTURAL SUPPLY CO. for Item 7 at an estimated cost of \$3,320; terms 2% 10 days, plus sales tax.


