BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for MID-CITY COMMERCIAL REVITALIZATION (PHASE 10) EL CAJON BOULEVARD (43RD - 44TH STREETS).

BE IT FURTHER RESOLVED, that the expenditure of \$335,000.00 from Mid-City Commercial Revitalization Project, CIP 39-083; \$330,000.00 from CDBG Fund 18523, Dept. 5633, Org. 3320; and \$5,000.00 from CDBG Fund 18525, Dept. 5883, Org. 8302, is hereby authorized solely and exclusively for providing funds for said project and related costs.


