WHEREAS, the vacation of the City's interest in an unneeded drainage easement affecting Lot 1679 of Mira Mesa Verde Unit 13-B, Map No. 6897, as more particularly shown on Drawing No. 17927-B attached hereto as Exhibit A, has been requested by the affected property owner; and

WHEREAS, the owner wishes to clear title to his land of all unnecessary easements in order to permit better utilization of the property; and

WHEREAS, the herein-described easement has not been used since 1976, and is surplus to City needs; and

WHEREAS, this action is exempt from the provisions of the California Environmental Quality Act of 1970 under City guidelines for implementation of said Act, as amended; NOW, THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego, as follows:

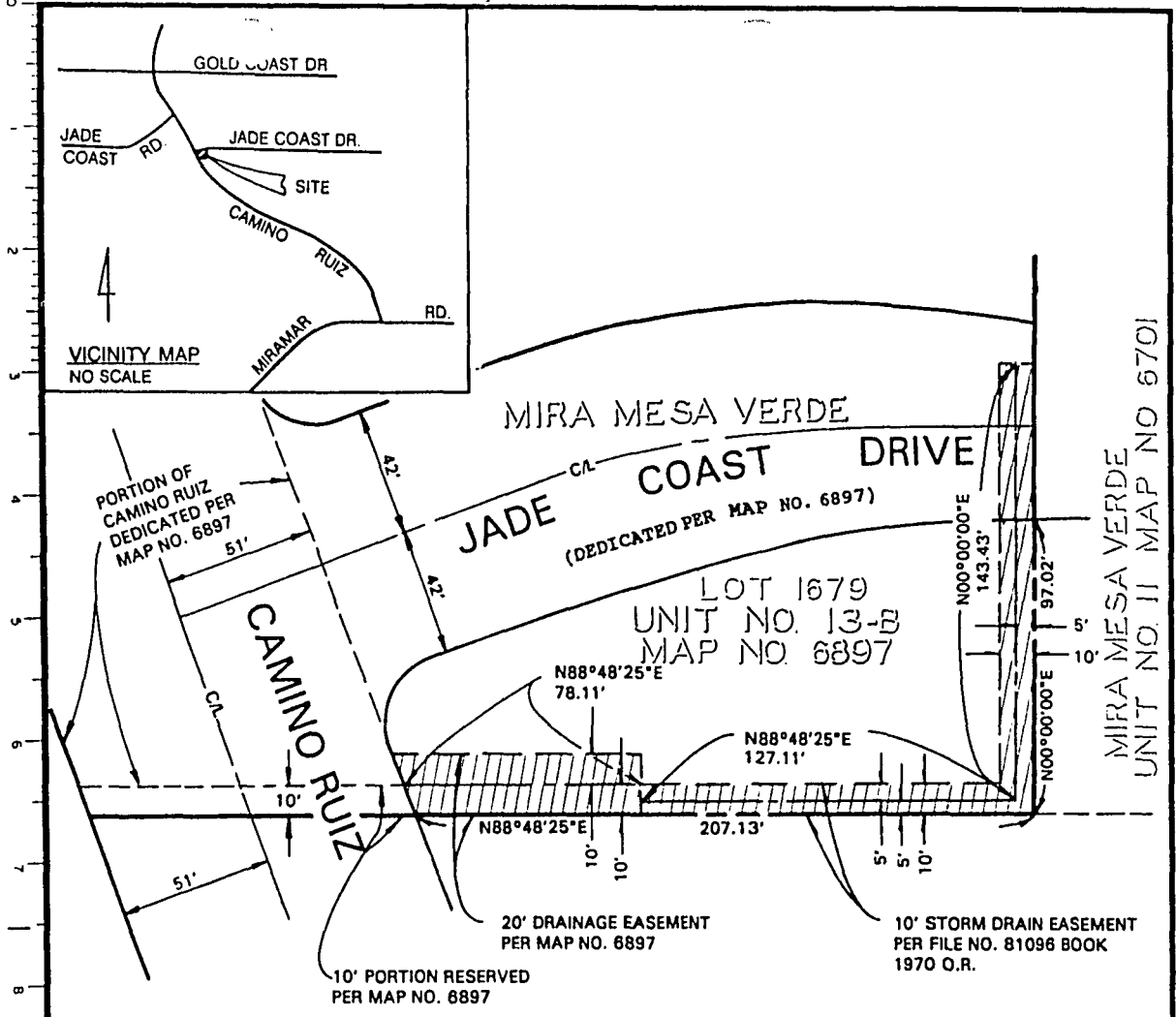
2. That the City Clerk of said City be, and he is hereby authorized and directed to cause a certified copy of this

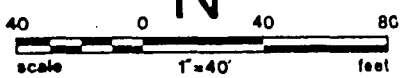
