RESOLUTION NUMBER R- 280743

ADOPTED ON SEP 29 1992

WHEREAS, in 1990 Government Code section 87306.5 was added to the Political Reform Act; and

WHEREAS, Government Code section 87306.5 requires that no later than July 1 of each even-numbered year, the City Council as the code reviewing body of local agencies' Conflict of Interest Codes, shall direct every local agency which has adopted a Conflict of Interest Code ("Code") to review its Code; and

WHEREAS, local agencies include not only City departments, but also City-owned Corporations, certain City board's and commissions, and certain other local agencies for whom the City Council serves as code reviewing body; and

WHEREAS, upon review of a local agency's Code, if no change in the Code is required, the local agency head shall submit a written statement to that effect to the code reviewing body no later than October 1 of the same year; and

WHEREAS, The City of San Diego's Transportation Demand Management Appeals Board ("Board") is a "local agency" within the meaning of Government Code section 87306.5; and

WHEREAS, by Resolution No. R-276876, adopted on November 19, 1990, the City Council adopted a Code governing this Board; and

WHEREAS, the City's Transportation Demand Management

Administrator has reviewed the Code and has determined that no change to the Board's Code is required or recommended at this time; and

WHEREAS, the City Manager concurs in the recommendation not to change the Board's Code at this time; NOW, THEREFORE,

BE IT RESOLVED, by the City Council that the City Manager's recommendation be adopted and that no change to the Transportation Demand Management Appeals Board's Conflict of Interest Code be made at this time.
