
RESOLUTION NUMBER R- 280752

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$150,000 from Fund 18528, Dept. 4030, Org. 3004, is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.
