## RESOLUTION NUMBER R-280757 ADOPTED ON SEPTEMBER 29, 1992

WHEREAS, Council authorized the City Manager to execute an amendment to the paramedic services agreement with Hartson Medical Services, by Resolution No. R-277053 on December 11, 1990, which extended their contract for two years and created a system using both Hartson paramedics and Fire Department firefighter/paramedics; and

WHEREAS, this shared system was implemented as a pilot program to improve service in areas of the city which experienced longer average ambulance response times, such as in the northern and southern parts of the city; and

WHEREAS, by placing a firefighter/paramedic on specific fire engines in these areas, advanced paramedic level life support was available several minutes earlier than was available by Hartson ambulance units; and

WHEREAS, at the time the shared system was developed, several Councilmembers requested that the concept of using firefighter/paramedics on fire engine companies be expanded when funding was available to include additional units within the urban core of the city where response volumes were high; and

WHEREAS, at the December 1990 meeting, Council also directed the City Manager to evaluate the shared system effectiveness; and

WHEREAS, the shared system has proven itself to be operationally effective; and

WHEREAS, it is now recommended that the shared system be expanded to include four additional fire stations in the City: Station 39 (Tierrasanta), Station 22 (Point Loma), Station 32 (Paradise Hills) and Station 17 (East San Diego/City Heights); NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized to expand the shared system for paramedic services by upgrading four existing engine companies [Station 39 (Tierrasanta), Station 22 (Point Loma), Station 32 (Paradise Hills) and Station 17 (East San Diego/City Heights] to paramedic assessment engine level and the shared system to be effective through June 30, 1993.
