RESOLUTION NUMBER R- 280772

ADOPTED ON SEP 29 1992

WHEREAS, the Police Department of The City of San Diego desires to apply for, and if selected to accept and expend, a grant award renewal of one hundred, fifty thousand, two hundred forty-three dollars (\$150,243.00) entitled "Refugee Assistance Project" from the Federal Office of Refugee Resettlement, via the California Department of Social Services; and

WHEREAS, the grant award renewal will be used to continue development and implementation of a program to assist target Indochinese, Ethiopian, and other refugee populations in San Diego; and

WHEREAS, the program consists of three community service officers who provide outreach, coordination, and education in victim services, crime prevention, and personal safety, one clerical assistant, and miscellaneous support equipment and supplies; and

WHEREAS, there is no requirement for matching funds and no additional City resources will be required to implement the program; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be, and is hereby, authorized to submit the grant application proposal, a copy of which is on file in the Office of the City Clerk, as Document No. RR- 280772, to the California Department of Social Services, who in turn will


submit it to the Federal Office of Refugee Resettlement, and he is further authorized to execute the grant proposal program, including any extensions or amendments thereof.

BE IT FURTHER RESOLVED, that any liability arising out of the performance of the grant award agreement, including civil court action for damages, shall be the responsibility of the grant recipient and the authorizing agency; the Federal Government, the Office of Refugee Resettlement, the State of California, and the Department of Social Services disclaim responsibility for any such liability.

BE IT FURTHER RESOLVED, that any grant funds received hereunder shall not be used to supplant expenditures controlled by this body.
