RESOLUTION REGARDING THE INITIATION OF THE BLACK MOUNTAIN DEVELOPMENT AGREEMENT PURSUANT TO COUNCIL POLICY 600-37.

WHEREAS, the Black Mountain Ranch project consists of approximately 4,170 acres and is located to the east of Fairbanks Ranch and to the northwest of Rancho Penasquitos within the northeast portion of The City of San Diego; and

WHEREAS, the site is zoned A1-10, R1-5000 and HR; and
WHEREAS, the property is located within the North City
Future Urbanizing Area Plan boundaries and the Rancho Penasquitos
Community Planning Area; and

WHEREAS, the current project proposes the development of two PGA golf courses, residential development, community parks, public and private open space, a potable water reservoir, a reclaimed water reservoir, public facilities and roads; and

WHEREAS, the City Planning Commission recommended initiation of the development agreement at its hearing on September 17, 1992; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that an initial determination is made that a development agreement for this project is warranted and staff is directed to accept the application for the development agreement and proceed with negotiations on this project.

BE IT FURTHER RESOLVED, that this initial determination is made because the development agreement has the opportunity to

provide extraordinary benefits to the City in the following areas:

- 1. Contributions to regional transportation networks above and beyond the necessary contributions for the proposed development.
- 2. Payment of school fees in excess of those required by current legislation.
- 3. Dedication of park lands which could not be exacted through the tentative map process.
