WHEREAS, the Director of the Department of Legislative Services issued Report No. 92-35 to the Honorable Mayor and members of the City Council regarding personal service contracts with state and federal lobbyists; and

WHEREAS, the current contracts for lobbying services with the City's state and federal lobbyists expire December 31, 1992;
NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the Director of the Department of Legislative Services be and is hereby directed to enter into negotiations of the current contracts for representation through the next state and federal legislative sessions with the City's state and federal lobbyists; and to broaden the scope of work within the contracts and negotiate with regard to broadening the representation either through the major partners or through subcontracting to designate additional scopes of work and additional expertise.
