BE IT RESOLVED, by the Council of The City of San Diego that the low and low acceptable bids of 1. PADRE JANITORIAL SUPPLIES, 2. NATIONAL SANITARY SUPPLY COMPANY, 3. CAMEO PAPER & JANITORIAL SUPPLY, 4. R-B ENTERPRISES, 5. SAFETY WEST, 6. AMERICAN CHEMICAL & SANITARY SUPPLY, 7. MISSION JANITORIAL SUPPLIES, 8. LOUKELTON DISTRIBUTING, 9. WAXIE SANITARY SUPPLY, 10. MAINTEX, INC. 11. C.M. SANITARY SUPPLY AND 12. BALL INDUSTRIES are hereby accepted and the City Manager is hereby authorized to execute contracts for the purchase of MISCELLANEOUS CUSTODIAL SUPPLIES as may be required for a period of one (1) year beginning October 1, 1992 through September 30, 1993 per prices on file in the Purchasing Department, as follows:

1. PADRE JANITORIAL SUPPLIES for Items 14, 17, 28, 29, 31, 36, 37, 42, 44, 47, 48, 60, 62, 64, 66, 70, 71, 73 and 80 at an estimated annual cost of \$41,942.60; terms net 30 days, plus tax, with options to renew the contract for four (4) additional one (1) year periods with option period increases not to exceed 10% of the prices in effect at the end of the prior contract period.
2. NATIONAL SANITARY SUPPLY COMPANY for Items 18, 22, 30, 45, 53 and 61 at an estimated annual cost of \$5,886.88; terms net 30 days, plus tax, with options to renew the contract

for four (4) additional one (1) year periods with option period increases not to exceed 5% of the prices in effect at the end of the prior contract period.

3. CAMEO PAPER & JANITORIAL SUPPLY for Items 40, 52, 54, 55, 56, 57 and 58 at an estimated annual cost of \$3,029.48; terms 1% 20 days, plus tax, with options to renew the contract for four (4) additional one (1) year periods with option period increases not to exceed 10% of the prices in effect at the end of the prior contract period.
4. R-B ENTERPRISES for Item 34 at an estimated annual cost of \$1,599.00; terms 1% 20 days, plus tax, with options to renew the contract for four (4) additional one (1) year periods with price increases for Period 1 not to exceed 15% of prices in effect at the end of the initial period, price increases for Period 2 not to exceed 20% of prices in effect at the end of Option Period 1, price increases for Period 3 not to exceed 25% of prices in effect at the end of Option Period 2, price increases for Period 4 not to exceed 35% of prices in effect at the end of Period 3.
5. SAFETY WEST for Items 8, 25, 26 and 27 at an estimated annual cost of \$658.36; terms 1% 10 days, plus tax, with options to renew for four (4) additional one (1) year periods with option period increases not to exceed 15% of the prices in effect at the end of the prior contract period.

6. AMERICAN CHEMICAL & SANITARY SUPPLY for Items 2, 3, 5, 9, 20, 23, 24, 49, 72, 78, and 82 at an estimated annual cost of \$8,269.51; terms net 30 days, plus tax.
7. MISSION JANITORIAL SUPPLIES for Items 32 and 68 at an estimated annual cost of \$1,935.00; terms net 30 days, plus tax, with options to renew the contract for four (4) additional one (1) year periods with option period increases not to exceed 5% of prices in effect at the end of the prior contract period.
8. LOUKELTON DISTRIBUTING for Items 11, 50, 59 and 67 at an estimated annual cost of \$2,414.23; terms net 30 days, plus tax, with options to renew for four (4) additional one (1) year periods with option period increases not to exceed 10% of prices in effect at the end of the prior contract period.
9. WAXIE SANITARY SUPPLY for Items 4, 6, 10, 15, 16, 19, 21, 35, 43, 51, 63, 74 and 79 at an estimated annual cost of \$21,585.59; terms net 30 days, plus tax, with options to renew for four (4) additional one (1) year periods with option period increases not to exceed 7% of prices in effect at the end of the prior contract period.
10. MAINTEX, INC. for Items 33, 65 and 81 at an estimated annual cost of \$3,176.78; terms net 30 days, plus tax.
11. C. M. SANITARY SUPPLY for Items 7, 38, 39, 41, 75, 76 and 77 at an estimated annual cost of \$4,342.30; terms net 30 days, plus tax, with options to renew for four (4) additional one (1) year periods with option period increases not to exceed

7% of prices in effect at the end of the prior contract period.

12. BALL INDUSTRIES for Items 1, 12 and 13 at an estimated annual cost of \$6,883.20; terms 1% 10 days, plus tax, with options to renew for four (4) additional one (1) year periods with option period increases not to exceed 5% of prices in effect at the end of the prior contract period.
