BE IT RESOLVED, by the Council of The City of San Diego, that the offer of HAWTHORNE MACHINERY CO., is hereby accepted and the City Manager is hereby authorized to execute a contract for RENTAL AND FULL MAINTENANCE OF FIVE (5) EACH CATERPILLAR 657E MOTOR SCRAPERS WITHOUT OPERATOR at a cost of \$198.00 per hour of operation for each machine and LEASE AND FULL MAINTENANCE OF ONE (1) CATERPILLAR 834B WHEELED DOZER WITH GRADING BOX WITHOUT OPERATOR at a cost of \$129.00 per hour of operation as may be required for a period of one month beginning approximately October 10 through November 9, 1992, for a total estimated cost of \$302,130.00; terms net 30 days plus sales tax, with options to (a) extend the rentals of any or all of the machines for up to six (6) additional months; (b) option to add two or more 657E scrapers, if required during the initial or extended rental periods; and (c) option to obtain equipment operators from Hawthorne Machinery Company, per prices on file in the Purchasing Department, if a sufficient number of City employed qualified operators are not available.
