

RESOLUTION NUMBER R- 280821

ADOPTED ON April 6, 1992

WHEREAS, the Planning Commission of The City of San Diego held various public hearings to consider the proposed Kearny Mesa Community Plan and Implementation Program; and

WHEREAS, a component of the program is to amend the Serra Mesa Community Plan to separate from it the Regional Employment Center of Kearny Mesa; and

WHEREAS, Council Policy No. 600-7 provides that public hearings to consider revisions of the PROGRESS GUIDE AND GENERAL PLAN FOR THE CITY OF SAN DIEGO may be scheduled concurrently with public hearings on proposed community plans; and

WHEREAS, the Progress Guide and General Plan land use map would be amended in order to retain consistency between the community plans; and

WHEREAS, Government Code Section 65361 provides that mandatory elements of the GENERAL PLAN may not be amended more than four times per year; and

WHEREAS, it is the intention of the City Council to conduct a public hearing on proposed actions that will result in changes to the PROGRESS GUIDE AND GENERAL PLAN during the year, but such changes shall not become effective until enacted at the semi-annual hearings conducted for the purpose of amending the PROGRESS GUIDE AND GENERAL PLAN FOR THE CITY OF SAN DIEGO; and

WHEREAS, the Kearny Mesa Implementation Program includes rezonings indicated on Zone Map Drawing No. C-798.3, on file in

the office of the City Clerk as Document No. 00-17942; and

WHEREAS, the Council of The City of San Diego has considered all maps, exhibits and written documents contained in the file for this project on record in The City of San Diego, and has considered all oral presentations given at the public hearing; NOW, THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That this City Council hereby approves the Kearny Mesa Community Plan, a copy of which is on file in the office of the City Clerk as Document No. RR-280821-1

2. That this City Council hereby approves an amendment to the Serra Mesa Community Plan, a copy of which is on file in the office of the City Clerk as Document No. RR-280821-2

3. That the Kearny Mesa Community Plan and the amendment to the Serra Mesa Community Plan shall become effective upon adoption of an appropriate amendment of the PROGRESS GUIDE AND GENERAL PLAN FOR THE CITY OF SAN DIEGO incorporating said plan and amendment at the next scheduled omnibus hearing.
