RESOLUTION NUMBER R- 280830  
ADOPTED ON OCT 06 1992

WHEREAS, Council Policy No. 600-7 provides that public hearings to consider revisions of the PROGRESS GUIDE AND GENERAL PLAN FOR THE CITY OF SAN DIEGO may be scheduled concurrently with public hearings on proposed community plan amendments in order to retain consistency between said plans; and

WHEREAS, the Planning Commission of The City of San Diego held concurrent public hearings on July 9 and July 30, 1992, to consider the rescission of the 1981 Mira Mesa Community Plan and the approval of the proposed 1992 MIRA MESA COMMUNITY PLAN update, associated rezones and amendments of the Progress Guide and General Plan and the Local Coastal Program; and

WHEREAS, the Planning Commission approved and recommended adoption by the City Council of said amendments and that the 1981 Mira Mesa Community Plan be rescinded; and

WHEREAS, the City Council has considered all maps, exhibits and written documents contained in the file for this project on record in The City of San Diego, and has considered the oral presentations given at the public hearing; NOW, THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That this City Council hereby approves the 1992 MIRA MESA COMMUNITY PLAN update, a copy of which is on file in the office of the City Clerk as Document No. RR- 280830 and rescinds the 1981 Mira Mesa Community Plan.

2. That the City Council hereby adopts an amendment of the PROGRESS GUIDE AND GENERAL PLAN FOR THE CITY OF SAN DIEGO to incorporate the above community plan update.

3. That this resolution shall not become effective with the coastal zone until such time as the California Coastal Commission unconditionally certifies these amendments as a Local Coastal Program amendment.
