
WHEREAS, on October 6, 1992, the Council of The City of San Diego held a public hearing for the purpose of considering an amendment to the First San Diego River Improvement Project Specific Plan ("FSDRIP"), the Development Agreement, Tentative Map and Mission Valley Permit; and

WHEREAS, San Diego Bond - MBM West, Limited, requested an amendment to First San Diego River Improvement Specific Plan District, the Development Agreement, a Tentative Map and a Mission Valley Development Permit to change the land use designation on the site to facilitate the development of 371 residential units as an alternative to commercial hotel use; and

WHEREAS, the City Council has considered all maps, exhibits and written documents contained in the file for this project on record in The City of San Diego, and has considered the oral presentations given at the public hearing; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that it hereby approves the amendment to the First San Diego River Improvement Specific Plan, a copy of which is on file in the office of the City Clerk as Document No. RR-280832.
