WHEREAS, the Council of The City of San Diego (the "City") has previously given its general approval to financing plans for the Central Imperial Study Area, of the Redevelopment Agency of The City of San Diego (the "Agency"); and

WHEREAS, the City has adopted the Fiscal Year 1992-93

Program Budget for the Southeast Economic Development Corporation

("SEDC"); NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

- 1. That the Auditor and Comptroller is hereby authorized to accept a loan repayment of \$310,000 from the Redevelopment Agency, Gateway Center East Project Area; and to appropriate \$310,000 to be loaned back to the Redevelopment Agency, Central Imperial Study Area to augment the study area.
- 2. That the Auditor and Comptroller is hereby authorized to transfer \$310,000 from the Contribution to the Redevelopment Agency Fund (10227) to the Redevelopment Agency for the purposes described above.
- 3. That the Auditor and Comptroller is hereby directed to record the above disbursements to the Central Imperial Study Area as interest bearing loans, to the Agency, upon adoption of the

study area, to be repaid as soon as practicable, from tax increment or other revenues.
