WHEREAS, the San Diego Association of REALTORS CanTree program has collected and donated over 72,000 tons of food in its five years of participation; and

WHEREAS, the San Diego Association of REALTORS CanTree program benefits Father Joe Carroll and the St. Vincent de Paul/Joan Kroc Center; and
