BE IT FURTHER RESOLVED, that the additional expenditure of \$147,000.00 from CIP No. 29-661.0, MEMORIAL COMMUNITY PARK - IMPROVEMENTS, PSD Fund 15000, to supplement funds previously authorized by Resolution No. R-280106 for MEMORIAL COMMUNITY PARK RECREATION CENTER IMPROVEMENTS, adopted on June 15, 1992, is hereby authorized solely and exclusively for said project and related costs.
