BE IT FURTHER RESOLVED, that the Purchasing Agent of the City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with the law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for REPLACEMENT AND UPGRADE OF CENTRE CITY TRAFFIC SIGNAL SYSTEM FROM BROADWAY TO MARKET STREET AND FROM FOURTH AVENUE TO SIXTH AVENUE.

BE IT FURTHER RESOLVED, that the expenditure of \$255,600.00 from CIP No. 68-011.0, ANNUAL ALLOCATION - MODERNIZE TOP 5-10 PRIORITIZED TRAFFIC SIGNALS, TransNet Fund 30300, is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller upon advice from the administering department, to retain excess monies, if any, in CIP 68-011.0.
